Sensory Details

Process Description	Apple Infused Sliced Sweetened Dried Cranberries are produced by infusing apple juice concentrate into superior grade cranberries, prepared from the sound, mature berries of the commonly cultivated cranberry plant (Genus/species - Vaccinium macrocarpon), until a specific equilibrate Brix range is reached. The product is then dried to moisture specification and lightly sprayed with oil.
